

WHAT IS PLANNED GIVING?

Planned Giving is a win-win approach to philanthropic donations that support your favorite nonprofit organization and can benefit you now or in the future.

Simply put, Planned Giving is the transfer of assets to a designated nonprofit organization during a lifetime or as part of an estate plan. This forward-thinking approach to giving is "planned" because often these assets are not liquid, have tax consequences and are generally transferred via a will or other written means.

GIVING THROUGH A PLANNED GIFT: Outright Gift

Make a quick and easy gift to VMC. Cash, stocks, bonds and/or mutual funds can all be donated. Donor may take an income tax deduction and avoid capital gains tax.



Will/Bequest

One of the easiest ways to give involves simply naming VMC as a beneficiary of your will or trust. A bequest may be for a particular amount or percentage

of your estate. Estate tax savings may be significant. Making a will or changing your will is a relatively easy process beginning with a call to your attorney.

Checking & Savings Accounts, IRA's

Often overlooked as a planned gift, these accounts are assets for which a donor can designate VMC as a beneficiary.

IRA Charitable Rollover

Individuals age 70½ or older can make tax-free gifts totaling up to \$100,000 from a traditional IRA account directly to qualified charities like VMC. While you cannot claim a charitable deduction for IRA gifts, the distribution counts towards your minimum required distribution and does NOT trigger income tax for you.

Life Insurance

Make a large gift to VMC with little cost. Donate a policy with VMC as owner and beneficiary. Donor can also name VMC as a full or partial beneficiary. Donor may receive an income tax deduction and possible future deductions.
