Showers, meals, laundry, computer access, mail services, classes, and social activities are provided as part of the program. In 2022, 279 individuals received services at the Resource Center and 39 individuals achieved permanent housing.

4b (Code:) (Expenses \$ 608,378 including grants of \$ 406,445) (Revenue \$) The Refuge provides homeless prevention services to households at risk of losing their housing. Individuals experiencing homelessness are provided with essential services and referrals. The Refuge is staffed primarily by trained volunteers under the direction of a social worker. 1,946 individuals were provided assistance in 2022 with 90 households provided with direct financial assistance and 355 households provided with linkage to the community rent and utility assistance program, KHA

4c (Code:) (Expenses \$ 184,183 including grants of \$ 44,260) (Revenue \$) The Volunteer Ministry Dental Clinic offers comprehensive dental services to individuals experiencing homelessness and other low-income, uninsured residents of Knox County. The clinic is staffed by a part-time dental assistant, a contract dentist, contract dental assistants, and volunteer dental professionals. The clinic is open 1-2 days per week depending on volunteer availability. In 2022, 756 individuals were served.
